

OFFICIAL RULES: ULTIMATE THANK YOU SWEEPSTAKES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID WHERE PROHIBITED.

THE PROMOTION (as defined below) IS SUBJECT TO THESE OFFICIAL RULES AND BY ENTERING, EACH ENTRANT UNCONDITIONALLY AGREES TO BE BOUND BY THEM.

1. Eligibility: The **ULTIMATE THANK YOU SWEEPSTAKES** Promotion (the “Promotion”) is open only to individuals who, at the time of entry, are (i) at least twenty-one (21) years old; (ii) are legal residents of one of the fifty (50) United States (including the District of Columbia) or Canada; and (iii) are eligible to participate in the Promotion and receive the Prize under their company/employer’s policies. The Promotion is void and not available to residents of Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions, overseas military installations, and where prohibited by law. Employees of Express Services, Inc. International Headquarters, its franchises and their internal staff, affiliates or subsidiaries, as well as any individual or entity involved with the design, production, execution, or distribution of Promotion or game pieces used in the Promotion, are not eligible to participate in the Promotion nor are any of their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year whether related or not). Participation constitutes your full and unconditional agreement to these Official Rules and Sponsor’s decisions concerning these Official Rules and the Promotion, which are final and binding in all matters related to the Promotion. Winning a Prize, as defined herein, is contingent upon fulfilling all requirements set forth herein. By entering into the Promotion, you (“Entrant”) represent and warrant that you (i) are age 21 or older; (ii) meet the eligibility requirements herein; and (iii) have read and agree to the terms and conditions herein on behalf of yourself and (where applicable) your company or employer.

Personally-identifying information of Entrants shall be used by Sponsor only with respect to this Promotion, and shall be destroyed after the end of the Promotion and the acceptance of Prizes, as defined herein, except to the extent Sponsor is required by law to maintain and/or disclose such information.

Multiple participants are not permitted to share the same email address. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries or registrations, which will be disqualified. In the event of a dispute as to any entry or registration, the authorized account holder of the email address used to enter or register will be deemed to be the Entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

By submitting an entry into the Promotion, you represent and warrant that you have received all rights, releases and permissions which may be necessary with respect to the content in your entry. Entries must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the entry is created. Sponsor may withdraw or disqualify an entry at any time without notice. Upon submission on an entry, such entries and the content contained with each entry shall become the sole and exclusive property of Sponsor and will not be returned.

5. Winner Selection. Prize Drawing: There are 22 potential prizes set forth in detail below.

Weekly winners will be drawn on August 5, 12, 19, and 26, 2019. Each drawing will result in five (5) winners receiving \$1,000 U.S. Funds in payment of a check[LRC2]. On Sept. 2, 2019 one U.S. U.S. and one Canadian entrant will be selected for the Ultimate Thank You prize of a \$10,000 vacation package. Winners will be randomly selected from all eligible online and print entries received during the Promotion Period. The first entry drawn will be eligible for the Prize and the Entrant of such entry will be notified by phone[LRC3]and[RRR4] email by September 3, 2019. A Winner will be required to respond to such notification within five (5) days of the first notification attempt or prize will be voided. Prize Winner shall also be required to complete W9 in the U.S. and in Canada a IRS W-8BEN or FORM 823, sign[LRC5] a Affidavit of Eligibility and Liability/Publicity Release, which must be completed, executed and returned within fourteen (14) days of the date on Affidavit of Eligibility and Liability/Publicity. Prize Winner’s travel companion (or if guest is a minor, his/her parent or legal guardian) shall also be required to sign and return a Liability/Publicity Release prior to travel.

[LRC8]If a potential Winner does not respond within five (5) days of the first notification attempt or within fourteen (14) days of the date on the Affidavit of Eligibility and Liability/Publicity Release or is returned as unclaimed or undeliverable, or if the potential Winner is found to be ineligible, or if he or she has not complied with or does not agree with these Official Rules or declines a Prize for any reason, such potential Winner shall be disqualified and shall forfeit his or her Prize and an alternate winner shall be selected from a second entry randomly selected by Sponsor. If there is still no confirmed Winner of the Prize after such attempts have been made, the Prize may go unawarded.

The foregoing process is the “Prize Selection Process.” Upon verification by Sponsor that the Entrant/potential Winner contacted by Sponsor as a potential Winner pursuant to the Prize Selection Process is eligible to win in accordance with these Official Rules, and upon agreement by the potential Winner of these Official Rules and acceptance of a Prize, the Entrant/potential Winner will be a “Prize Winner” or “Winner” as used herein.

Ultimate Thank You – Express Travel Gift Certificate: The value of the Express Travel Gift Certificate is \$7,000. Travel must be booked and completed by September 30, 2020. Certificate must be redeemed 60 days in advance of travel. Valid toward air, hotel, tour, or cruise package. No VRBO, AirBnB, or Homeaway rentals or cabins. Certificate is non-transferable and must be used in full.

Ultimate Thank You – \$3,000 Cash Prize: Funds will be distributed in U.S. value at the time of presentation. Funds will be distributed via check sent via Fed-Ex. Funds will be paid when the travel gift certificate is redeemed and booked.

Prizes are non-transferable, cannot be sold or gifted, may not be redeemed for cash, and will not be replaced if lost or stolen. Should the Winner or Winner’s guest elect not to partake in any or all portions of his/her Prize and/or with no guest, all said portions of the Prize shall be forfeited and no alternative prize or compensation of any kind shall be awarded for forfeited prize elements and shall not be subject to further or alternative compensation. A valid credit or debit card will be required to guarantee Ultimate Thank You Prize Winner’s hotel room on check in. All elements of the Prize are subject to availability; if unavailable, experiences and items of a similar nature and value may be offered at the discretion of Sponsor or person/entity providing Prize on behalf of Sponsor; once confirmed, the Prize cannot be amended or cancelled; all Prize elements must be redeemed at the same time during a single trip; all travelers will require valid photo ID approved for air travel; any necessary visas or insurance are the responsibility

of the Winner and guest; travel is subject to availability at the time of booking; other travel restrictions and blackout dates may apply; all airline tickets are subject to the vagaries of flight variation, work stoppages, and schedule or route changes. No airline miles will be awarded. Travel over holidays and other peak travel periods are restricted. This trip may not be sold. Airline tickets must be used on the carrier ticketed and cannot be used on any other airline. Prize Winner may be required to furnish his/her social security number for the sole purpose of preparation of any tax forms as required by law. Winner may be issued an IRS Form 1099 for the ARV of his/her awarded Prize.

ARV for Prize may vary depending upon various factors, including travel times and points of departure and destination and fare fluctuations. The ARV for Prize is an estimate made before the Promotion begins.

7. Entry Conditions and Release. By entering, each participant, Entrant, and Winner, and by accompanying Winner, Winner's guest, agree to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Promotion; (b) release and hold harmless the Sponsor and its parent, subsidiary, and affiliated companies and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Promotion or the game pieces, websites and online forms used in connection with the Promotion, and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability for any reason under any theory, whether arising under contract, statute or tort (including but not limited to negligence) and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Promotion, acceptance or use or misuse of Prize (including any travel or activity related thereto), the broadcast, exploitation or use of

entry and/or the inability to use all or any element of the Prize; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to the Promotion and/or acceptance, use, inability to use or misuse of a Prize.

8. Publicity. Except where prohibited by law, acceptance of a Prize constitutes Winner's consent to Sponsor's and its agents' use of Winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration. IF ENTRANT IS CHOSEN AS A PRIZE WINNER, ENTRANT'S PERSONAL IDENTIFYING INFORMATION MAY BE DISCLOSED TO THIRD PARTIES INCLUDING, WITHOUT LIMITATION, PLACING ENTRANT'S NAME ON A WINNER'S LIST AS REQUIRED BY STATE LAW.

9. General Conditions. Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, for any reasons, including, but not limited to, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner or if the Entrant's entry is deemed to be obscene, unlawful, vulgar, lewd, derogatory, inappropriate, or otherwise not in good taste, as determined in Sponsor's sole discretion. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Limitations of Liability. All participants, Entrants, Winner, and Winner's guest (if any) participate in the Promotion and use and/or accept elements of the Prize at their own risk. The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether or not caused by Entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; (5) any injury or damage to persons or property which may be caused, directly or

indirectly, in whole or in part, from Entrant's participation in the Promotion or receipt or use or misuse of any Prize; and/or (6) the unavailability of any Prize element or the inability of any Entrant to receive the Prize under applicable law, rule or policy. If for any reason an Entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, Entrant's sole remedy is another entry in the Promotion play, provided that if it is not possible to award another entry due to discontinuance of the Promotion, or any part of it, for any reason, Sponsor, at its discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the Prizes offered herein.

11. Disputes. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations hereunder and in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Oklahoma, without giving effect to any choice of law or conflict of law rules (whether of the State of Oklahoma or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Oklahoma. Any and all disputes, claims and causes of action arising out of or connected with this Promotion or any Prizes awarded shall be resolved individually without resort to any form of class action. Any disputes, claims, or controversies arising out of or concerning the Promotion, the Prize or these Official Rules, shall be resolved exclusively through arbitration. This agreement to arbitrate is intended to be construed broadly and shall survive the Promotion. The arbitration shall be conducted in accordance with the Commercial Arbitration Rules of the American Arbitration Association and shall be undertaken pursuant to the Federal Arbitration Act. The arbitration shall be held in Oklahoma City, Oklahoma. The decision of the arbitrator shall be final, conclusive, and binding and enforceable in any court of competent jurisdiction. Each party shall bear its own costs and attorneys' fees in connection with the arbitration. The arbitrator shall not award punitive or consequential damages, and the parties hereby waive any rights to such damages.
